6,828 LOCATIONS ACROSS THE GLOBE Wendy's (NASDAQ: WEN) is one of the largest quick service restaurant chains in the industry and #2 in traffic share among QSR burger chains in the United States in 2020. The company was founded by Dave Thomas in 1969 in Columbus, OH, and has since grown to 6,828 locations and 14,000 employees in 31 countries (2020). Despite the Covid-19 pandemic, Wendy's achieved its 10th consecutive year of same restaurant sales growth in the United States, doubled its digital sales, and improved profit margin by 3.3%. The company successfully launched its breakfast menu in March of 2020, which has been highly profitable and accounted for 7% of total sales in fiscal 2020.

Cherry Creek 101 is a Rochester Hills-based operator of Wendy's restaurants throughout Michigan. Originally founded in 2008, the company has since grown to more than 30-units with the majority of sites located in the Detroit metro area. Cherry Creek's founder, Edward Liversidge, has worked with Wendy's for more than 40 years and at one point oversaw the Cleveland, OH; Akron, OH; Buffalo, NY, and Roanoke, VA regions.
















# MADISON HEIGHTS, MI

Madison Heights is a densely populated suburb located three miles north of downtown Detroit. Madison Heights is situated between Royal Oak and Warren, two of Detroit's largest suburbs with a total population of more than 175,000 people. Madison Heights is part of Automation Alley, an Advanced Manufacturing Hub that facilitates public-private partnerships by connecting business leaders with education and government to fuel Michigan's economy and accelerate innovation. Other economic drivers in and near Madison Heights include General Motor's Technical Innovation Center, a 710-acre campus that employs 17,000 people and TACOM, which has ties to the US Army and employs 6,500 people. Dequindre Rd. is one of the primary retail arteries serving Madison Heights. Immediately south of the subject property there's a Target anchored shopping center that also includes Marshalls, Burlington, Petco, Kroger, MJR Universal Theatres, T-Mobile, Del Taco, Chase Bank, Starbucks, White Castle, Huntington Bank, and TCF Bank. Other national retailers within a half mile radius include Chemical Bank, Taco Bell, Burger King, KFC, Checkers, Arby's, 7-Eleven, O'Reilly Auto Parts, and Dairy Queen. Ascension Macomb-Oakland Hospital, a full-service hospital with a Level III Trauma Center, is 1.2 miles south of the subject property.
